



2017-2018 Violent and Criminal Report

The Texas Education Code requires every district to publish a report on violent and criminal incidents at their schools that is available for use and review by the public in the district. According to TEC §39.306 this report shall include:

- a statement of the number, rate, and type of violent or criminal incidents that occurred on each district campus, to the extent permitted under the Family Educational Rights and Privacy Act of 1974 (20 U.S.C. Section 1232g),
- information concerning school violence prevention and violence intervention policies and procedures that the district is using to protect students, and
- the findings that result from evaluations conducted under the Safe and Drug-Free Schools and Communities Act of 1994 (20 U.S.C. Section 7101 et seq.)

School Violence Prevention and Violence Interventions provided by Benavides ISD to protect students:

Violence Prevention

BISD works to ensure there is a consistent management of discipline throughout the district.

Prevention begins with well-informed students, parents and staff.

BISD makes available an electronic version of the District Student/Parent Handbook. A hard copy is available by request. The Handbook contains the District Student Code of Conduct that provides written expectations for student behavior as well as disciplinary procedures and consequences.

School personnel review and reinforce rules and expectations throughout the school year.

Anonymous Alert for Bully Reporting Procedures are in place.

Coordination with Benavides Policy Department and Duval County Sheriff's Department.

Guidance and Counseling Program – each Benavides ISD campus has one certified counselor. Counselors conduct classroom lessons, group sessions, and/or individual sessions on socially acceptable alternatives to violent behavior.

- Surveillance Cameras
- Canine Drug and Weapon Detection
- Student Code of Conduct
- Bullying Prevention Speakers
- Policy FFI/FFH (Local)
- Extra-curricular activities that promote student safety and teach students to get along with one another.

Violence Interventions

BISD violence intervention policies and procedures are aligned with Senate Bill 133 Chapter 37 and the Texas Penal Code including:

- Local ISS/OSS/DAEP (In-School Suspension, Out-of-School Suspension, Disciplinary Alternative Educational Program);
- School Board policies that specify what must occur when a person has not complied with KISD regulations; employees are made aware of these policies through the *Policies and Procedures Manual*, distributed annually; and
- Crisis Management Teams, in place at each campus.
